



OBTAINING PERMISSIONS & RELEASES

If you use material from a book, magazine, newspaper, website or any other source, you must get permission to use this material. The only exception is fair use or if the material is in the public domain. As a writer who wishes to use information or excerpts from other sources, you must obtain permission from the copyright owner. Look on the copyright page for a book and you will find the publisher, title, author's name and copyright notice.

A release is required if you take a photo and use the photo of a person in your publication. You must have written permission from the person you photographed.

OBTAINING PERMISSIONS & RELEASES

Checklist for Obtaining Permissions

- Δ Title of book and author's name
 - Δ Define exact excerpts, chapter, page numbers, paragraphs, specific lines, number of words
 - Δ Provide copyright page from publisher's book
 - Δ Title of your book and co-authors
 - Δ Your publisher's name
 - Δ Title of your publication
 - Δ Check those which apply:
 - Hardcover – trade paperback Mass Market – Textbook – Magazine
 - Newsletter –Newspaper – Electronic book – website – Other_____
 - Δ Your publication date
 - Δ Cover price
 - Δ Number of pages
 - Δ Territory: World in all languages – World in English – U.S., (its territories, possessions, seven dependences) and Canada
 - Δ Any changes, adaptations, condensations must be approved by publisher/author
 - Δ No additions, or added artwork/substitute illustrations without publisher's consent
 - Δ Use for subsequent editions
 - Δ Use in a book club will require an additional fee
 - Δ Excerpts used are not assignable or transferable
 - Δ Publisher's credit notice will be printed
